What is Title I?

- Title I is a <u>federal grant program</u> designed to give educational assistance to students living in areas of high poverty.
- This federal program provides funding to local school districts to <u>improve the academic achievement</u> of disadvantaged students.
- The Title I program originated in 1965 when Congress passed the Elementary and Secondary Education Act.
- That Act is periodically reauthorized by Congress, and often given a new name. The No Child Left Behind Act in 2001 was a reauthorization of the Elementary and Secondary Education Act (Title I).

What is the Purpose of Title I?

The purpose of Title I is to

"Ensure that all children have a fair, equal, and significant opportunity to obtain a high-quality education and reach, at a minimum, proficiency on challenging state academic standards and state academic assessments."

Perry Elementary Schoolwide Title I Program

- Perry Elementary is a schoolwide Title I program.
- A schoolwide program allows schools to use resources effectively and efficiently to undertake comprehensive reform of the <u>entire educational</u> <u>program in the school</u>.
- This program design will assist all children, particularly the lowest achieving children, to meet the high state academic achievement standards.

Criteria for a Schoolwide Title I Program

- A Schoolwide program plan must be based on and include three core elements:
- 1) <u>Comprehensive Needs Assessment</u> that analyzes the academic achievement of all groups of students
- 2) <u>Comprehensive Plan</u> that reforms the total instructional program.
- 3) Annual Program Evaluation which measures the implementation and results of the schoolwide program.

Perry Elementary Title I Supplemental Instruction

- Title I provides support to students who are below benchmark for their grade level in reading and math.
- Title I supplemental instruction program is intended to supplement, not replace, classroom reading and math instruction.
- Students will receive their primary reading and math instruction in the classroom with their classroom teacher.
- Title I supplemental instruction may take place during independent work time, transition time, enrichment time, or small group time.

Title I Supplementary Instruction Reading - Entrance Criteria

- **Title I staff and classroom teachers** examine a <u>variety</u> of factors that may indicate a student needs additional academic intervention.
 - Aimsweb Plus Universal Screener
 - DRA 2(Developmental Reading Assessment)
 - Teacher Recommendation
 - M-STEP (State Assessment)
- Students exhibiting the greatest number of indicators are selected to participate in the Title I program.

Title I Supplementary Instruction Reading - Exit Criteria

- Students are formally screened through Aimsweb Plus testing and assessed with the DRA every September, January, and May. At those times, Title I staff and grade level teachers <u>re-examine</u> which students exhibit the greatest number of indicators.
- In between assessment periods, students meeting benchmark standards through progress monitoring may be exited from the Title I program.
- All students who have been exited from the Title I program will continue with progress monitoring.
- When a student exits Title I reading, <u>parents will be notified</u>.

Title I Supplemental Instruction Math - Entrance Criteria

- **Title I staff and classroom teachers** examine a <u>variety</u> of factors that may indicate a student needs additional academic intervention.
 - Aimsweb Plus Universal Screener
 - Teacher Recommendation
- Students exhibiting the greatest number of indicators are selected to participate in the Title I program.

Title I Supplemental Instruction Math - Exit Criteria

- Students are formally screened through Aimsweb testing every September, January, and May. At those times, Title I staff and grade level teachers <u>re-examine which students</u> <u>exhibit the greatest number of indicators</u>.
- In between assessment periods, students meeting benchmark standards through progress monitoring may be exited from the Title I program.
- All students who have been exited from the Title I program will continue with progress monitoring.
- When a student exits Title I reading, <u>parents will be</u> <u>notified</u>.
